What data do we collect?

Forestdale Football Club collects the following data:

- Personal identification information (Name, email address, phone number)
- Players identification information (Name, DOB, school)

How do we collect your data?

You directly provide Forestdale Football Club with most of the data we collect. We collect data and process data when you:

- Voluntarily complete the registration form on our website
- Use or view our website via your browser's cookies.

How will we use your data?

Forestdale Football Club collects your data so that we can:

- Register your child with Forestdale Football Club
- Email you with Club updates and information where necessary



How do we store your data?

Forestdale Football Club securely stores your data in our password protected database and encrypted on our website. Forestdale Football Club will keep your personal data for the duration of your time as part of the club. Once you have notified us that you will no longer be part of the club, we will delete your data by removing it from our secure player database and website.

What are your data protection rights?

Forestdale Football Club would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – You have the right to request Forestdale Football Club for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification – You have the right to request that Forestdale Football Club correct any information you believe is inaccurate. You also have the right to request Forestdale Football Club to complete the information you believe is incomplete.
- The right to erasure – You have the right to request that Forestdale Football Club erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that Forestdale Football Club restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to Forestdale Football Club's processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that Forestdale Football Club transfer the data that we have collected to another organization, or directly to you, under certain conditions.
